And it is further agreed by and between the said parties hereto, that the said mortgagor,   I   to hold and enjoy the said premises until default of payment shall be made. But if   I   shall make default in the payment of said monthly installments, or shall make default in any of the covenants and provisions hereinabove set out for a space of thirty days, then, and in such event, the Association, may, at its option, declare the whole amount hereunder at once due and payable, together with costs and a reasonable attorney's fee, and shall have the right to foreclose its mortgage.
