TO ALL WHOM THESE PRESENTS MAY CONCERN:

Margaret Inez Payne Davis (hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto **Citizens Lumber Company**

(hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of **Two Thousand Fifty and No/100**

DOLLARS (\$ 2050.00),

with interest thereon from date at the rate of **six (6%)** per centum per annum, said principal and interest to be repaid:

PAYABLE: in monthly installments of \$30.00 on the 16th day of each month hereafter to be applied first to interest then to principal until paid in full with interest thereon from date at the rate of six (6%) per cent, per annum, to be computed semiannually and paid monthly

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee pursuant to the covenants herein and also in consideration of the further sum of Three (\$3.00) Dollars to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, his heirs, successors and assigns:

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, **on the eastern side of the Dunham Bridge Road, near the City of Greenville, being shown as Lot No. 8 on plat of the property of Thomas Clifton Collins, made by W. J. Riddle, Surveyor, in August 1945, and described as follows:**

BEGINNING at a stake on the eastern side of the Dunham Bridge Road 252 feet south from the Easley Bridge Road at corner of Lot No. 7, and running thence with the line of said lot S. 48-25 E. 478.2 feet to a stake; thence S. 15-56 W. 76.9 feet to a stake corner of Lot No. 9; thence with the line of said lot N. 49-56 W. 491.8 feet to a stake on the Dunham Bridge Road; thence with the eastern side of the Dunham Bridge Road N. 27-56 E. 84 feet to the beginning corner.

Being the same premises conveyed to the mortgagor by deed recorded in Deed Book 305 at Page 121.

It is understood and agreed that this mortgage is junior in lien to a mortgage held by Citizens Lumber Company in the amount of \$1000.00 recorded in Mortgage Book 557 at Page 238, AND a mortgage held by Citizens Lumber Company in the amount of \$2000.00 recorded in Mortgage Book 357 at Page 278.

Together with all and singular the rights, members, hereditaments, and appurtenances to the same belonging or in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures and any other equipment or fixtures now or hereafter attached, connected, or fitted thereto in any manner; it being the intention of the parties hereto that all such fixtures and equipment, other than the usual household furniture, be considered a part of the real estate.
