All that piece, parcel or lot of land with the buildings and improvements thereon, situate, lying and being on the Western side of Ottaway Drive in the city of Greenville, in the County of Greenville, State of South Carolina, being known and designated as Lot # 40 as shown on a plat of Lanneau Drive, Highlands, which plat is recorded in the R.M.C. Office for Greenville County, South Carolina in Plat Book "D" at pages 288 and 289.
