Dollars, in and by our certain promissory note in writing of even date herewith, due and payable
on the day of 19

To be repaid \$40.00 per month beginning one (1) month from date.

with interest
from date at the rate of Five (5%) per centum per annum
until paid; interest to be computed and paid monthly and if unpaid when due to
bear interest at same rate as principal until paid, and we have further promised and agreed to pay ten per
cent of the whole amount due for attorney's fee, if said note be collected by attorney or through legal
proceedings of any kind, reference being thereunto had will more fully appear.

NOW, KNOW ALL MEN, That we, the said Joe Tollison and Leota S. Tollison

in consideration of the said debt and sum of money
aforesaid, and for the better securing the payment thereof, according to the terms of the said note, and
also in consideration of the further sum of Three Dollars, to us in hand well and truly paid at and before
the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, have granted,
bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said
South Carolina National Bank of Greenville, S. C., its successors and
assigns forever.

All that piece, parcel or lot of land in Greenville Township,
Greenville County, State of South Carolina, being known and designated
as Lot No. 3, as shown on plat of property of Rucy Ragsdale Graham,
made by Piedmont Engineering Service, dated October, 1947; reference
to which is hereby made for a more complete description;

BEGINNING at an iron pin on the corner of a fifteen-foot
alley and county road, and running thence with said county road
S. 26-53 E. 100 feet to iron pin at joint corner of Lots Nos. 3 and
4; thence N. 59-14 E. along joint line of Lots Nos. 3 and 4, 200 feet
to iron pin; thence along joint line of Lots Nos. 3 and 6, S. 26-53
E. 100 feet to said 15-foot alley; thence along said alley S. 59-14
W. 200 feet to beginning corner.

Also, all that piece, parcel, or lot of land in Greenville
Township, Greenville County, State of South Carolina, about three
miles West of the City of Greenville, near State Highway No. 13,
and being known and designated as Lot No. 4 as shown on plat of
property of Ruby Ragsdale Graham made by Piedmont Engineering Ser-
vice, dated October, 1947, and having the following metes and bounds,
to-wit:

BEGINNING at a stake on the East side of a County Road at
corner of Lot No. 3 and running thence along line of said Lot No.
3, N. 59-15 E. 200 feet to a stake in line of Tract 4; thence with
line of Tract 4, N. 21-30 W. 100 feet to stake in line of Tract 5;
thence with line of Tract 5, S. 59-14 W. 200 feet to stake on East
side of County Road; thence with East side of County Road, S. 21-
30 E. 100 feet to the beginning corner.
