WHEREAS, the Mortgagor is well and truly indebted unto Francis Wayne Bouchillon (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of Three Thousand and No/100

DOLLARS (\$ 3000.00 );

with interest thereon from ~~date~~ maturity at the rate of six (6%) per centum per annum, said principal and interest to be repaid:

PAYABLE: March 1, 1963, with interest thereon from after maturity at the rate of six (6%) per cent, per annum, to be computed and paid after maturity

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee pursuant to the covenants herein and also in consideration of the further sum of Three (\$3.00) Dollars to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, his heirs, successors and assigns:

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Greenville Township, at the northwestern corner of Welcome Avenue and Mary Street, near the City of Greenville, shown as Lot 117 on Map No. 2 of Camilla Park made by W. J. Riddle in December, 1943, recorded in Plat Book M at Page 85, and described as follows:

BEGINNING at a stake on the northwestern corner of Welcome Avenue and Mary Street, and running thence with the northern side of Welcome Avenue S. 59-30 W. 150 feet to a stake at corner of Lot 81; thence with the lines of Lots 86, 87 and 88, N. 6-42 W. 203.3 feet to a stake at corner of Lot No. 116; thence with the line of said lot S. 87-52 E. 187 feet to a stake on Mary Street; thence with the western side of Mary Street S. 2-08 W. 76 feet to a stake; thence continuing with Mary Street S. 35-18 W. 53.6 feet to the beginning corner.

Being the same property inherited by the mortgagor from Vernelle J. Bouchillon and conveyed to him by E. Inman, Master, by deed to be recorded herewith.

It is understood and agreed that this mortgage is junior in lien to a mortgage executed to Fidelity Federal Savings & Loan Association in the original amount of \$6500.00 by the mortgagor herein of even date.

Together with all and singular the rights, members, hereditaments, and appurtenances to the same belonging or in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures and any other equipment or fixtures now or hereafter attached, connected, or fitted thereto in any manner; it being the intention of the parties hereto that all such fixtures and equipment, other than the usual household furniture, be considered a part of the real estate.
