I, **ALAN L. WILKINS** of
Greenville, South Carolina, hereinafter called the Mortgagor, send(s) greetings:

WHEREAS, the Mortgagor is well and truly indebted unto

AIKEN LOAN & SECURITY COMPANY

, a corporation organized and existing under the laws of South Carolina, hereinafter called the Mortgagee, as evidenced by a certain promissory note of even date herewith, the terms of which are incorporated herein by reference, in the principal sum of **Nine Thousand Seven Hundred Fifty Dollars (\$9,750.00)**, with interest from date at the rate of **five & one-fourth** per centum (**5 1/4%**) per annum until paid, said principal and interest being payable at the office of **Aiken Loan & Security Company** in **Florence, South Carolina**, or at such other place as the holder of the note may designate in writing, in monthly installments of **Sixty-five and 72/100** ----- Dollars (\$ **65.72**), commencing on the first day of **November**, 19 **57**, and on the first day of each month thereafter until the principal and interest are fully paid, except that the final payment of principal and interest, if not sooner paid, shall be due and payable on the first day of **October**, 19**77**.

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt and for better securing the payment thereof to the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell, and release unto the Mortgagee, its successors and assigns, the following-described real estate situated in the County of **Greenville**, State of South Carolina:

All that lot of land in the County of Greenville, State of South Carolina, being Lot No. 17 and the southern one-half of Lot No. 18, Block C, on plat of **MAYFAIR ESTATES**, recorded in Plat Book S, page 72-73 of the R.M.C. Office for Greenville County, S. C., and having according to said plat and a recent survey made September 1957 by **R. W. Dalton, Engineer**, the following metes and bounds, to wit:

BEGINNING at an iron pin on the southeast side of Mayfair Drive, the front joint corner of Lots Nos. 16 and 17; thence with the joint line of said lots, S. 60-48 E. 150 feet to an iron pin, corner of Lot No. 7; thence with the rear line of Lots Nos. 7 and 6, N. 29-12 E. 75 feet to an iron pin in the center of the rear line of Lot No. 18; thence through the center of Lot No. 18, N. 60-48 E. 150 feet to an iron pin on the southeast side of Mayfair Drive; thence with the southeast side of said Mayfair Drive, S. 29-12 W. 75 feet to the point of beginning.

Together with all and singular the rights, members, hereditaments, and appurtenances to the same belonging or in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures and equipment now or hereafter attached to or used in connection with the real estate herein described.
