TO ALL WHOM THESE PRESENTS MAY CONCERN:

MYRTLE SIMPSON (hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of Twenty-five Hundred and No/100 ----- DOLLARS (\$ 2500.00), with interest thereon from date at the rate of six (6%) per centum per annum, said principal and interest to be repaid as therein stated, and

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the northern side of Logan Street in the City of Greenville, being shown as Lot 8 on plat of property of William G. Sirrine recorded in Plat Book A at Page 161, and described as follows:

BEGINNING at a stake on the northern side of Logan Street 150 6/7 feet west from Wardlaw Street at the corner of Lot 6 and running thence with the line of said lot N. 18-30 W. 100 feet to a stake; thence N. 71-30 E. 48 feet to a stake at corner of Lot 9; thence with the line of said lot S. 18-30 E. 100 feet to a stake on Logan Street; thence with the northern side of said street S. 71-30 W. 48 feet to the beginning corner.

Being the same property conveyed to the mortgagor by deed of the Trustees of the Protestant Episcopal Church in Upper South Carolina, a Corporation, by deed to be recorded herewith.
