TO ALL WHOM THESE PRESENTS MAY CONCERN:

SOULA W. FINLEY (hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of **Eighteen Thousand and No/100** ----- DOLLARS (\$ 18,000.00 ), with interest thereon from date at the rate of **five & one-half (5½%)** per centum per annum, said principal and interest to be repaid as therein stated, and

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purpose:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Gantt Township, about three miles from Greenville Courthouse and being shown as Tract No. 3 on plat of property of H. S. Garrison, recorded in Plat Book U at Page 19, and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on the western side of Highway #29, corner of property of H. S. Garrison and running thence with the line of said property N. 79-45 W. 451.1 feet to an iron pin; thence continuing with the line of property of H. S. Garrison, N. 25-53 E. 200 feet to pin; thence S. 79-45 E. 451.1 feet to Highway #29; known as Grove Road; thence with the western side of said highway S. 25-35 W. 200 feet to the beginning corner.

Being the same premises conveyed to the mortgagor by deed recorded in Deed Book 483, Page 153.

ALSO: All that lot of land in the City of Greenville, S. C., on the north side of Sullivan Street, and being more particularly described as follows:

BEGINNING at a point on Sullivan Street at a point 110 feet 4½ inches from the northwest intersection of Sullivan and Augusta Streets and running thence along Sullivan Street S. 89 W. 79 feet 7½ inches to an iron pin on Sullivan Street; thence N. 12 W. 60 feet to an iron pin; thence N. 89 E. 81 feet 7 inches to an iron pin; thence S. 12 E. 60 feet to the point of beginning. Being the same premises conveyed to the mortgagor by Deed recorded in Deed Book 184 at Page 262. ALSO: the adjacent strip of land described as follows: BEGINNING at a point on Sullivan Street joint corner of Sula Mae Finley and C. O. Strange and running thence N. 15 W. 60 feet to the joint corner of the Finley and Strange lots; thence S. 85-05 E. 6 feet to an iron pin in line of Strange lot; thence S. 0-29 W. 59.4 feet to the beginning corner on Sullivan Street. Being the same premises conveyed to the mortgagor by deed recorded in Deed Book 393 at Page 197.

Together with all and singular the rights, members, hereditaments, and appurtenances to the same belonging or in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures and any other equipment or fixtures now or hereafter attached, connected, or fitted thereto in any manner; it being the intention of the parties hereto that all such fixtures and equipment, other than the usual household furniture, be considered a part of the real estate.
