J. A. Hart (hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto **The South Carolina National Bank as Executor of the Estate of William C. Cleveland, Jr.**, (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of **Ten Thousand and No/100--**

DOLLARS (\$10,000.00),

with interest thereon from date at the rate of **five & 1/4** centum per annum, said principal and interest to be repaid:

One year after date, with the privilege of anticipating all or any part of the unpaid balance on any interest date, with interest thereon at the rate of five and one-fourth percent from date to be computed and paid semi-annually

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee pursuant to the covenants herein and also in consideration of the further sum of Three (\$3.00) Dollars to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, his heirs, successors and assigns:

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the southern corner of Marlin Street and the New Buncombe Highway, near the City of Greenville, being a portion of Lots Nos. 53, 54, 55 and 56, as shown on plat of Perry Estate recorded in Plat Book H at Page 184, and described as follows:

BEGINNING at a stake at the southern corner of New Buncombe Highway and Marlin Street, and running thence with the southeastern side of Marlin Street, S. 58-30 W. 194.3 feet to a stake in line of Lot No. 52; thence with the line of said lot S. 31-30 E. 77.1 feet to a stake in line of property of E. S. Starnes; thence with the line of said property N. 61-30 E. 150.1 feet to a stake on New Buncombe Road; thence with the right-of-way of New Buncombe Road, N. 3-50 W. 100.8 feet to the beginning corner.

Being the same premises conveyed to the mortgagor by deed recorded in Deed Book 327 at Page 67.

Together with all and singular the rights, members, hereditaments, and appurtenances to the same belonging or in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures and any other equipment or fixtures now or hereafter attached, connected, or fitted thereto in any manner; it being the intention of the parties hereto that all such fixtures and equipment, other than the usual household furniture, be considered a part of the real estate.
