Greenville Township, Greenville County, State of South Carolina, and being known and designated as Lot No. 74 of the Mountain View Land Company property, as shown on plat thereof recorded in the R.M.C. Office for Greenville County in Plat Book "A" at pages 396 and 397, and having the following metes and bounds, according to said plat, to wit:
