WHEREAS, Mortgagor is indebted to Mortgagee for money loaned, to secure the payment of which Mortgagor has executed and delivered to Mortgagee a note of even date herewith, in the principal sum of -----

All of that piece, parcel or lot of land, with the buildings and improvements thereon, situate, lying and being near the City of Greenville, in the County of Greenville, State of South Carolina, being known and designated as Lot No. 50, Belle Meade Subdivision, as per plat thereof recorded in the R.M.C. Office for Greenville County, South Carolina, in Plat Book "EE", pages 116 and 117, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the Southerly side of Pine Creek Drive, joint corner with Lot 51, and running thence S. 23-48 W. 119.7 feet to an iron pin at the corner of Lot 49; thence along the line of Lot 49 S. 76-22 E. 134.1 feet to an iron pin on the Westerly side of Williamsburg Drive; thence along Williamsburg Drive N. 11-33 E. 85 feet to an iron pin at the intersection of Williamsburg Drive and Pine Creek Drive; thence around the curve of the said intersection, the chord of which is N. 30-33 W. 37.2 feet to an iron pin on Pine Creek Drive; thence along Pine Creek Drive N. 72-40 W. 85 feet to an iron pin, the point of beginning.
