To ALL WHOM THESE PRESENTS MAY CONCERN: We, S. Lee Templeton and Polly G. Templeton, of Greer, S.C., hereinafter called the Mortgagor, send (s) greetings:

WHEREAS, the Mortgagor is well and truly indebted unto

RATTERREE-JAMES INSURANCE AGENCY

, a corporation organized and existing under the laws of the State of South Carolina, hereinafter called the Mortgagee, as evidenced by a certain promissory note of even date herewith, the terms of which are incorporated herein by reference, in the principal sum of Nine Thousand ----- Dollars (\$ 9,000.00), with interest from date at the rate of Five & one-fourth per centum (5 1/4 %) per annum until paid, said principal and interest being payable at the office of Ratterree-James Insurance Agency in Greer, S.C., or at such other place as the holder of the note may designate in writing, in monthly installments of Sixty and 66/100 ----- Dollars (\$ 60.66), commencing on the first day of December, 19 57, and on the first day of each month thereafter until the principal and interest are fully paid, except that the final payment of principal and interest, if not sooner paid, shall be due and payable on the first day of November, 19 77.

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt and for better securing the payment thereof to the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell, and release unto the Mortgagee, its successors and assigns, the following-described real estate situated in the County of Greenville, State of South Carolina:

All that certain parcel or lot of land situated on the north side of Cannon Avenue in the City of Greer, Chick Springs Township, Greenville County, State of South Carolina, being an unnumbered lot of the M.T. Gaines Property lying between Lots Nos. 17 and 18 of said Property, and being shown on a plat thereof recorded in Plat Book "D", pages 260-263, R.M.C. Office for Greenville County, and being particularly shown as the Property of S. Lee and Polly G. Templeton according to survey and plat thereof by H.S. Brockman, Registered Surveyor, dated October 23, 1957, recorded in Plat Book 00, page 64, R.M.C. Office for said County, having a uniform width of 100 feet, with a depth of 189.5 on the east side and 188.5 feet on the west side.
