in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof, according to the terms of the said note, and also in consideration of the further sum of Three Dollars, to me in hand well and truly paid at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said

C. E. Robinson, as Trustee under B. M. McGee Trust Deed, his successors and assigns forever:

All that lot of land in Greenville County, South Carolina being known as Lot #69 on Lynhurst Drive of Section I of Oak-Crest as shown by a plat thereof made by C. C. Jones and recorded in the Greenville County R. M. C. Office in Plat Book GG at pages 130 and 131, and having, according to said plat, the following metes and bounds:

BEGINNING at a pin at the corner of Lot #68 on Lynhurst Drive and running thence S. 60-02 W. 80 feet to the corner of Lot #70; thence with the line of Lot #70, S. 29-58 E. 150 feet to a pin the rear line of Lot #94; thence with the rear line of Lot #94, N. 60-02 E. 80 feet to a pin in the rear corner of Lot #68; thence with the line of Lot #68, N. 29-58 W. 150 feet to the point of beginning.
