TO ALL WHOM THESE PRESENTS MAY CONCERN:

LEONA YOUNG PHILLIPS, and SHIRLEY ANN PHILLIPS and JOSEPH FRANKLIN PHILLIPS, JR., by their (hereinafter referred to as Mortgagor) SEND(S) GREETING: General Guardian, Leona Young Phillips,

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of One Thousand and No/100 -----

DOLLARS (\$ 1000.00 ), with interest thereon from date at the rate of six (6%) ---- per centum per annum, said principal and interest to be repaid as therein stated, and

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purpose:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Greenville Township, being known as Lot No. 1, Block K, Fair Heights, according to plat recorded in the R. M. C. Office for Greenville County in Plat Book F at Page 257, and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin at the southwestern intersection of Cumberland Avenue and Decatur Street, and running thence along Decatur Street N. 58-40 W. 140 feet to a point at the rear corner of Lot 24; thence along the rear line of Lot 24 S. 31-20 W. 50 feet to a point at the joint rear corner of Lots 23 and 24; thence along the dividing line of Lots 1 and 2, S. 58-40 E. 140 feet to a point on the west side of Cumberland Avenue; thence along the western side of Cumberland Avenue N. 31-20 E. 50 feet to the point of beginning.

Being the same property conveyed to J. F. Phillips by deed recorded in Deed Book 337 at Page 194. J. F. Phillips died intestate on the 19th day of September, 1954, leaving as his sole heirs, Leona Young Phillips, his wife, Shirley Ann Phillips, his daughter, and Joseph Franklin Phillips, Jr., his son. Judge W. B. McGowan of the Greenville County Court has ordered that Leona Young Phillips sign the note and mortgage for the minors, Shirley Ann Phillips, and Joseph Franklin Phillips, Jr., in Judgment Roll G 10,657 in the Office of Clerk of Court for Greenville County.

Together with all and singular the rights, members, hereditaments, and appurtenances to the same belonging or in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures and any other equipment or fixtures now or hereafter attached, connected, or fitted thereto in any manner; it being the intention of the parties hereto that all such fixtures and equipment, other than the usual household furniture, be considered a part of the real estate.
