proceedings of any kind, reference being thereunto had will more fully appear.

aforesaid, and for the better securing the payment thereof, according to the terms of the said note, and
also in consideration of the further sum of Three Dollars, to me in hand well and truly paid at and before
the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, have granted,
bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said
C. E. Robinson, as Trustee under the B. M. McGee Will, his successors and
assigns forever:

All that piece, parcel or lot of land situate, lying and being in
Bates Township, Greenville County, South Carolina and being known and desig-
nated as Lot No. 16 on a plat of Property of E. S. Bulman prepared by J. C.
Hill, September 24, 1949 and recorded in the R. M. C. Office for Greenville
County in Plat Book "BB", page 35 and having according to said plat the follow-
ing metes and bounds, to-wit:

BEGINNING at an iron pin on the southeast side of a County Road
at the corner of Lot No. 15 heretofore conveyed to Ruby Tilley and running thence
along the line of that lot S. 66-00 E. 513 feet to an iron pin in the line of a 9.70
acre tract; thence along the line of that tract in a southwesterly direction 137.2 feet
to an iron pin at the rear corner of Lot. No. 17; thence along the line of Lot No. 17
N. 62-30 W. 571 feet to an iron pin on the southeastern side of the said County Road;
thence along the line of said County Road N. 48-00 E. 103 feet to the beginning
corner.
