bear interest at same rate as principal until paid, and have further promised and agreed to pay ten per
cent of the whole amount due for attorney's fee, if said note be collected by attorney or through legal
proceedings of any kind, reference being thereunto had will more fully appear.

NOW, KNOW ALL MEN, That I, the said Harold T. Hall

in consideration of the said debt and sum of money
aforesaid, and for the better securing the payment thereof, according to the terms of the said note, and
also in consideration of the further sum of Three Dollars, to me in hand well and truly paid at and before
the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, have granted,
bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said
Susie E. Bowen, her heirs and assigns forever.

All that certain piece, parcel or lot of land situate, lying
and being in the State of South Carolina, County of Greenville and
within the City of Greenville, on the South side of Gallivan Street,
being known and designated as Lot No. 8, of a subdivision known as
North Park Addition, according to a plat thereof recorded in the
R. M. C. Office for Greenville County in Plat Book "K", at page 89
and having, according to the said plat, the following metes and bounds,
to-wit:

BEGINNING at an iron pin on the South side of Gallivan Street
at the corner of Lot No. 7, and running thence with the line of said
Lot No. 7, S. 24-30 W. 169 feet to a stake in a branch; thence down
said branch, approximately 65.2 feet to a stake in the rear line of
Lot No. 9; thence with the line of said Lot No. 9, N. 24-30 E. 178 feet
to an iron pin on the South side of Gallivan Street; thence with the
South side of Gallivan Street, N. 65-30 W. 65 feet to the beginning
corner.

Being the same conveyed to Georgia McC. Vaughn by Harriet
Walker Goodman by deed dated January 4, 1952 and recorded in the
R. M. C. Office for Greenville County in Vol. 448, at page 521.

The above described lot is shown on the Township Block
Book at Sheet 35, Block 2, Lot 1-G.
