organized and existing under the laws of South Carolina, hereinafter
called the Mortgagee, as evidenced by a certain promissory note of even date herewith, the terms of which
are incorporated herein by reference, in the principal sum of ELEVEN THOUSAND FIVE HUNDRED & NO/100
Dollars (\$ 11,500.00), with interest from date at the rate of five & one-fourth per centum
(5 1/4 %) per annum until paid, said principal and interest being payable at the office of
C. Douglas Wilson & Co., in Greenville, South Carolina, or
or at such other place as the holder of the note may designate in writing, in monthly installments of
Sixty-Nine & No/100----- Dollars (\$ 69.00),
commencing on the first day of February, 19 58, and on the first day of each month there-
after until the principal and interest are fully paid, except that the final payment of principal and interest,
if not sooner paid, shall be due and payable on the first day of January, 19 83.

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt and for better
securing the payment thereof to the Mortgagee, and also in consideration of the further sum of Three
Dollars (\$3) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing
and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained,
sold, and released, and by these presents does grant, bargain, sell, and release unto the Mortgagee, its
successors and assigns, the following-described real estate situated in the County of Greenville,
State of South Carolina:

All that piece, parcel or lot of land, with the buildings and
improvements thereon, situate, lying and being near the City
of Greenville, in the County of Greenville, State of South
Carolina, being known and designated as Lot 82, Section 1, on
Plat of Oak-Crest, which plat is recorded in the R. M. C. Office
of Greenville County, South Carolina, in Plat Book G G, pages
130-131, and having according to said plat the following metes
and bounds, to wit:

BEGINNING at an iron pin on the westerly side of Templewood Drive,
joint front corner Lots 81 and 82, said iron pin being 23.3 feet
in a southeasterly direction from the intersection of McClain
Avenue and Templewood Drive; and running thence S. 75-03 W. 150
feet to an iron pin; thence S. 15-04 E. 80 feet to an iron pin,
joint rear corner Lots 82 and 83; thence N. 75-03 E. 150 feet to
an iron pin on Templewood Drive, joint front corner Lots 82 and 83;
thence N. 14-57 W. 80 feet along Templewood Drive to an iron pin
to the point of BEGINNING.

Together with all and singular the rights, members, hereditaments, and appurtenances to the same belong-
ing or in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be
had therefrom, and including all heating, plumbing, and lighting fixtures and equipment now or hereafter
attached to or used in connection with the real estate herein described.

To HAVE AND TO HOLD, all and singular the said premises unto the Mortgagee, its successors and
assigns forever.
