Stokes and Pearl Petty Stokes** -----, to the Land Bank Commissioner, securing the payment of the principal sum of -----
Two thousand ----- Dollars (\$ **2000.00**), dated the 20 day of July , 1934 , and recorded in the public records for **Greenville** County, State of **South Carolina** , in Mortgage Book **239** , at page **12** , the property hereinafter described, to-wit:

All that certain parcel or tract of land containing six and eighty-three hundredths (6.83) acres, more or less, in Highland Township, Greenville County, South Carolina, more particularly described on plat prepared by H. S. Brockman, R. S., dated August 20, 1957, as follows: From the northeast corner of the property described in said mortgage run along old factory road South 10 degrees West 8.50 chains and South 20 degrees West 9.50 chains for the point of beginning; thence run South 77 degrees 30 minutes West 557 feet; thence South 12 degrees 34 minutes East 516.3 feet; thence North 87 degrees 32 minutes East 582.7 feet to said road; thence along the road North 39 degrees West 177.5 feet and North 5 degrees West 462 feet to the POINT OF BEGINNING.
