Six months after date, with interest thereon from maturity at the rate of six (6%) per cent, per annum, to be computed and paid semi-annually, until paid in full;

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagoe at any time for advances made to or for his account by the Mortgagor pursuant to the covenants herein and also in consideration of the further sum of Three (\$3.00) Dollars to the Mortgagor in hand well and truly paid by the Mortgagoe at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagoe, his heirs, successors and assigns:

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville,

near the City of Greenville, being shown as Lots Nos. 18, 40, 24, 31, 32, 43, 47, 48, 51 and 52 as shown on Plat of Grand View made by Woodward Engineering Company recorded in the R.M.C. Office for Greenville County in Plat Book KK, at page 93.

It is understood and agreed that the lien of this Mortgage is junior to the following Mortgages:

(1) Mortgage held by Eliza T. Looper recorded in Mortgage Book 708, page 148, in the sum of \$50,000.000 of which \$1,250.00 is secured by the within lots.

(2) Mortgage held by H. K. Townes in the sum of \$4,500.00 recorded in Mortgage Book 720, page 450, covering Lot No. 18. (3) Mortgage held by H. K. Townes recorded in Mortgage Book

717, page 93, in the sum of \$4,500.00 covering Lot No. 40. (4) Mortgage held by H. K. Townes in the sum of \$27,000.00 recorded in Mortgage Book 725, page 257, covering Lot No. 18 and others.

(5) Mortgage held by H. K. Townes in the sum of \$27,000.00 recorded in Mortgage Book 725, page 269, covering Lots Nos. 24, 31, 32, 43, 47, 48, 51, 52 and others; but the total amount due to H. K. Townes on all of these Mortgages is \$9,000.00 with interest.
