All that piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the City of Greenville, County of Greenville, State of South Carolina, being known and designated as Lot No. 296, as shown on a plat entitled "Pleasant Valley" prepared by Dalton & Neves dated April, 1946 and recorded in the R. M. C. Office for Greenville County, S. C., in Plat Book BB at page 163 and having according to said plat the following metes and bounds:
