All that piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in Paris Mountain Township, Greenville County, South Carolina, being known and designated as Lot No. 15 of Pine Grove Heights, plat of which is recorded in the R. M. C. Office for Greenville County in Plat Book Y at page 87 and having according to said plat the following metes and bounds, to-wit:
