DAVID C. WILSON (hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of Forty-one Hundred Fifty and No/100 ----- DOLLARS (\$ 4150.00), with interest thereon from date at the rate of six (6%) per centum per annum, said principal and interest to be repaid as therein stated, and

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Austin Township, being described as follows:

BEGINNING at an iron pin on the western side of a 10 foot private road which point is 209.5 feet S. 24-45 E. from the public road and running thence N. 75-45 E. 104.8 feet to a stake on line of John Herbert; thence along the line of John Herbert property S. 24-15 E. 104.75 feet to a stake in line of lot of Carl Davis; thence along Davis line S. 72-19 W. 104 feet to an iron pin on the western side of a 10 foot private road; thence along the western edge of said lot N. 24-45 W. 110.15 feet to the beginning corner, together with all my right, title and interest in said 10 foot drive-way above referred to.
