TO ALL WHOM THESE PRESENTS MAY CONCERN:

EDWIN G. JONES AND BEATRICE K. JONES (hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of Six Thousand Two Hundred and No/100 ----- DOLLARS (\$ 6200.00), with interest thereon from date at the rate of five & three-fourth per centum per annum, said principal and interest to be repaid as therein stated, and (5 3/4%)

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purpose:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in the City of Greenville, on the northern side of Rutherford Road and being shown as Lot 16 of Block C on a plat of Croftstone Acres recorded in Plat Book S at Pages 78 and 79 and described as follows:

BEGINNING at a stake on the northern side of Rutherford Road 293 feet east from Summitt Drive at the corner of Lot 17 and running thence with the line of said road in a northerly direction 290 feet to a stake in line of Lot 4; thence with the lines of Lots 4 and 5 in an easterly direction 94.8 feet to a stake in line of Lot S (sold); thence with line of said lot in a southerly direction 277.7 feet to a stake on Rutherford Road; thence with the northern side of said road S. 72-54 W. 100 feet to the beginning corner.

Being the same property conveyed to the mortgagors by deed recorded in deed Book 404 at Pge. 51.

Together with all and singular the rights, members, hereditaments, and appurtenances to the same belonging or in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures and any other equipment or fixtures now or hereafter attached, connected, or fitted thereto in any manner; it being the intention of the parties hereto that all such fixtures and equipment, other than the usual household furniture, be considered a part of the real estate.
