WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of Three Thousand and No/100 -----

DOLLARS (\$ 3000.00), with interest thereon from date at the rate of six (6%) per centum per annum, said principal and interest to be repaid as therein stated, and

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Greenville Township, at the southeast corner of the intersection of Parker Road and Ohio Street, known as Lot 45, on plat of Monaghan Annex, recorded in Plat Book C at Page 65, and described as follows:

BEGINNING at an iron pin at the corner of the intersection of Parker Road and Ohio Street, and running thence with the eastern side of Ohio Street, S. 37½ W. 195 feet to iron pin, corner of Lot 44; thence with line of Lot 44 S. 83 E. 94 feet to an iron pin at rear corner of Lot 43; thence with the line of Lot 43 in a northeasterly direction 150 feet to iron pin on Parker Road; thence with the southern side of Parker Road N. 51-3/4 W. 48 feet to the point of beginning.

Said premises being the same conveyed by H. H. Kerns to Maude Edwards Bruce by deed recorded in Volume 233 at Page 56, and devised to the mortgagor by will of Maude Edwards Bruce, by will filed in Apartment 593, File 13, in the office of Probate Court for Greenville County.

Together with all and singular the rights, members, hereditaments, and appurtenances to the same belonging or in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures and any other equipment or fixtures now or hereafter attached, connected, or fitted thereto in any manner; it being the intention of the parties hereto that all such fixtures and equipment, other than the usual household furniture, be considered a part of the real estate.
