well and truly indebted to

in the full and just sum of SIX HUNDRED & NO/100 (\$600.00) -----

Dollars, in and by our certain promissory note in writing of even date herewith, due and payable

in consecutive monthly installments of Twenty (\$20.00) Dollars commencing on the first day of February 1958 and continuing thereafter on the 1st. day of each and every succeeding month until paid in full, said payments to be first applied against interest and the balance against the principal

with interest from date at the rate of six per centum per annum until paid; interest to be computed and paid monthly as stated above and if unpaid when due to bear interest at same rate as principal until paid, and we have further promised and agreed to pay ten per cent of the whole amount due for attorney's fee, if said note be collected by attorney or through legal proceedings of any kind, reference being thereunto had will more fully appear.

NOW, KNOW ALL MEN, That we, the said Jackson T. Redmon and Jewel G. Redmon

in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof, according to the terms of the said note, and also in consideration of the further sum of Three Dollars, to us in hand well and truly paid at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Roy S. Batson and Sarah M. Batson, their heirs and assigns:

All that piece, parcel or lot of land in the State and County aforesaid, in Gantt Township, on the South side of Stevenson Lane, being shown as Lot 37, on Plat of Dixie Farms, made by Dalton & Neves, Engineers, December 1939, recorded in the R. M. C. Office for Greenville County in Plat Book L, at page 5, and having, according to said Plat the following courses and distances, to-wit:

BEGINNING at an iron pin at the Southwest corner of intersection of Stevenson Lane and Welcome View Drive and running thence along the West side of Welcome View Drive S. 25-06 E. 250 feet to an iron pin; thence S. 60-47 W. 158.6 feet to an iron pin; thence with line of Lot 38, N. 26-35 W. 258 feet to an iron pin on the South side of Stevenson Lane; thence with Stevenson Lane N. 63-47 E. 165 feet to the beginning corner.

The lien of this mortgage is junior to that certain other mortgage executed by the Grantors to the Grantees and recorded in Mortgage Book 689, at page 386.
