WHEREAS, the Mortgagor is well and truly indebted unto

CANAL INSURANCE COMPANY

, a corporation organized and existing under the laws of the State of South Carolina, hereinafter called the Mortgagee, as evidenced by a certain promissory note of even date herewith, the terms of which are incorporated herein by reference, in the principal sum of **Thirteen Thousand One Hundred Dollars (\$13,100.00)**, with interest from date at the rate of **Five & one-fourth per centum (5 1/4%)** per annum until paid, said principal and interest being payable at the office of **Canal Insurance Company** in **Greenville, South Carolina**, or at such other place as the holder of the note may designate in writing, in monthly installments of **Seventy-eight and 60/100**----- Dollars (\$ 78.60), commencing on the first day of **March**, 19 58, and on the first day of each month thereafter until the principal and interest are fully paid, except that the final payment of principal and interest, if not sooner paid, shall be due and payable on the first day of **February**, 19 83.

ALL that lot of land with the buildings and improvements thereon, situate on the East side of Chipley Lane, near the City of Greenville, in Greenville County, State of South Carolina, being shown as Lot No. 80 on plat of Chestnut Hills, made by R. K. Campbell, Surveyor, March, 1954, recorded in the RMC Office for Greenville County, S. C., in Plat Book GG, pages 64 and 65; said lot fronting 75 feet along the East side of Chipley Lane, running back in depth 155.8 feet on the North side, to a depth of 135.9 feet on the South side, and being 72 feet across the rear.
