TO ALL WHOM THESE PRESENTS MAY CONCERN:

J. RANDOLPH TAYLOR (hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of Twelve Thousand and No/100

DOLLARS (\$ 12,000.00 ), with interest thereon from date at the rate of five & one-half (5½%) per centum per annum, said principal and interest to be repaid as therein stated, and

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purpose:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the eastern side of S. Calhoun Street in the City of Greenville, and having according to a plat recorded in Plat Book F at Page 386 the following metes and bounds, to-wit:

BEGINNING at an iron pin on the eastern side of S. Calhoun Street at the corner of S. Calhoun Street and a 15 feet alley and running thence with S. Calhoun Street N. 16-17 E. 45 feet to an iron pin; thence S. 73-18 E. 97.4 feet to an iron pin; thence S. 16-17 W. 45 feet to an iron pin on the northern edge of a 15 feet alley; thence with said alley to the southeastern corner of building located on said lot and continuing along the southern side of said building and the northern side of said alley N. 73-18 W. 97.4 feet to an iron pin, point of beginning.

Subject, however, to an easement over a five feet strip along the northern side of said lot for a common driveway as created by instrument recorded in Deed Book 566 at Page 217.

Said premises being the same conveyed to the mortgagor by deed recorded in Deed Book 565 at Page 55.

Together with all and singular the rights, members, hereditaments, and appurtenances to the same belonging or in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures and any other equipment or fixtures now or hereafter attached, connected, or fitted thereto in any manner; it being the intention of the parties hereto that all such fixtures and equipment, other than the usual household furniture, be considered a part of the real estate.
