"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, being at the norteast intersection of Palmer Street (an unopened Street formally known as Hartsell Ave.), and Maple Street (formerly Main St.), in that section known as "Greenline" in the City, Township and County of Greenville, being part of lot #11, on plat of Mrs. A. C. Davis Property, prepared by C. M. Furman, February 1921, and having the following metes and bounds, towit:
