of Greenville, S. C. , hereinafter called the Mortgagor, send(s) greetings:

WHEREAS, the Mortgagor is well and truly indebted unto AIKEN LOAN & SECURITY COMPANY

, a corporation organized and existing under the laws of South Carolina , hereinafter called the Mortgagee, as evidenced by a certain promissory note of even date herewith, the terms of which are incorporated herein by reference, in the principal sum of Eleven Thousand Two Hundred Fifty Dollars (\$11,250.00 ), with interest from date at the rate of five & one-fourth per centum (5 1/4 %) per annum until paid, said principal and interest being payable at the office of Aiken Loan & Security Company in Florence, S. C. , or at such other place as the holder of the note may designate in writing, in monthly installments of Seventy-five and 83/100 -----Dollars (\$75.83 ), commencing on the first day of April , 19 58 , and on the first day of each month thereafter until the principal and interest are fully paid, except that the final payment of principal and interest, if not sooner paid, shall be due and payable on the first day of March , 19 78 .

Now, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt and for better securing the payment thereof to the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell, and release unto the Mortgagee, its successors and assigns, the following-described real estate situated in the County of Greenville , State of South Carolina:

All those lots of land in the county of Greenville, state of South Carolina, known and designated as Lots Nos. 15, 16, and 17 on plat of BUCKHORN HILLS recorded in Plat Book EE at page 147 of the RMC Office for Greenville County, S. C., and having according to said plat and a recent survey made February 1958 by R. W. Dalton, the following metes and bounds, to-wit:

Beginning at an iron pin on the northern side of Honeysuckle Lane, the joint front corner of Lots Nos. 14 and 15; thence with the joint line of said lots N. 1-18 W. 167.9 feet to an iron pin; thence N. 77-30 E. 220.4 feet to an iron pin on the southeast side of Buckhorn Road; thence with the southeast side of said road; S. 25-10 W. 172 feet to an iron pin; thence with the curve of said road as it intersects with Honeysuckle Lane, the chord of which is S. 20-54 E. 31 feet to an iron pin on the northeast side of Honeysuckle Lane; thence with the northeast side of said Lane, S. 54-44 E. 81.8 feet to an iron pin; thence S. 76-45 E. 75.1 feet to an iron pin; thence N. 70-45 E. 55.1 feet to an iron pin; thence N. 75-10 E. 45 feet to an iron pin; thence continuing with the northeast side of Honeysuckle Lane, N. 84-10 E. 45 feet to the beginning corner.

Together with all and singular the rights, members, hereditaments, and appurtenances to the same belonging or in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures and equipment now or hereafter attached to or used in connection with the real estate herein described.

To HAVE AND TO HOLD, all and singular the said premises unto the Mortgagee, its successors and assigns forever.

The Mortgagor covenants that he is lawfully seized of the premises hereinabove described in fee simple absolute, that he has good right and lawful authority to sell, convey, or encumber the same, and that the
