(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville,

on the Geer Highway (U.S. Hwy. #276), in Marietta, S. C., and being more fully described as follows:

BEGINNING at an iron pin at Northeast intersection of Geer Highway and Katherine Street, and running thence with said Highway, N. 8-15 W. 206.9 feet to iron pin; thence S. 81-15 W. 374.1 feet to an iron pin; thence S. 89-30 W. 197.5 feet to an iron pin on branch; thence up branch as the line 240 feet, more or less to an iron pin; thence N. 78-20 W. 711 feet to an iron pin on another branch below spring; thence down this branch 895.3 feet to the forks of last mentioned branch; thence up said branch as the line 654 feet, more or less, to an iron pin; thence S. 89-20 E. 686.1 feet to the beginning corner, and containing 11.14 acres, more or less.
