WHEREAS, the Mortgagor is well and truly indebted unto

THE PRUDENTIAL INSURANCE COMPANY OF AMERICA

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt and for better securing the payment thereof to the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell, and release unto the Mortgagee, its successors and assigns, the following-described real estate situated in the County of Greenville, State of South Carolina:

ALL that lot of land with the buildings and improvements thereon, situate on the West side of Chipley Lane, near the City of Greenville, in Greenville County, South Carolina, shown as Lot 105 on Plat of Chestnut Hills, prepared by R. K. Campbell, Surveyor, March 18, 1954, recorded in the RMC Office for Greenville County, S. C., in Plat Book "GG", pages 64 and 65; said lot fronting 67 feet on the West side of Chipley Lane, running back to a depth of 188.5 feet on the South side, to a depth of 173.5 feet on the North side, and being 75 feet across the rear.
