I, David H. McCraw, of
Greenville, South Carolina, hereinafter called the Mortgagor, send(s) greetings:

WHEREAS, the Mortgagor is well and truly indebted unto

Fidelity Federal Savings & Loan Association

, a corporation organized and existing under the laws of United States of America, hereinafter called the Mortgagee, as evidenced by a certain promissory note of even date herewith, the terms of which are incorporated herein by reference, in the principal sum of Sixty-Five Hundred and No/100 Dollars (\$ 6500.00), with interest from date at the rate of Five & One-Fourth per centum (5 1/4 %) per annum until paid, said principal and interest being payable at the office of Fidelity Federal Savings & Loan Association in Greenville, South Carolina, or at such other place as the holder of the note may designate in writing, in monthly installments of Thirty-Nine and No/100- - - - Dollars (\$39.00), commencing on the first day of April, 19 58, and on the first day of each month thereafter until the principal and interest are fully paid, except that the final payment of principal and interest, if not sooner paid, shall be due and payable on the first day of March, 19 83.

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt and for better securing the payment thereof to the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell, and release unto the Mortgagee, its successors and assigns, the following-described real estate situated in the County of Greenville, State of South Carolina:

All that certain piece, parcel or lot of land in Greenville County, State of South Carolina, on the Northern side of Prancer Avenue, in the City of Greenville, being shown as lot # 268, on a plat of Pleasant Valley, recorded in Plat Book P at Page 92, and described as follows:

BEGINNING at a stake on the Northern side of Prancer Avenue, at the corner of lot # 267, and running thence with the line of said lot, N. 0-08 W. 160 feet to a stake; thence S. 89-52 W. 60 feet to a stake at the corner of lot # 269; thence with the line of said lot, S. 0-08 E. 160 feet to a stake on Prancer Avenue; thence with the Northern side of said Avenue, N. 89-52 E. 60 feet to the beginning corner.

Being the same premises conveyed to the mortgagor by Caroline B. Moseley by deed to be recorded.
