(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Chick Springs Township, on the Eastern side of Broadmoor Drive, being shown and designated as lot # 44, on plat of Section Two of Lake Forest Heights, recorded in Plat Book XX at Page 105, R.M.C. Office for Greenville County, and having, according to said plat, the following metes and bounds, to-wit:

"BEGINNING at an iron pin on the Eastern side of Broadmoor Drive, at the joint front corner of lots # 44 and 45, and running thence with the line of lot # 45, N. 84-32 E. 161 feet to an iron pin in rear line of lot # 51; thence with the rear line of lots # 51 and 52, S. 2-55 E. 130.8 feet to an iron pin at the rear corner of lot # 43; thence with the line of lot # 43, S. 86-51 W. 172.3 feet to an iron pin on Broadmoor Drive; thence with the Eastern side of Broadmoor Drive, N. 2-28 E. 125 feet to the point of beginning."
