to be paid \$55.00 120 days from date and \$55.00 each succeeding month thereafter until paid in full, with payments to be applied first to the semi-annual interest payments and then to the principal

with interest

from 90 days after date at the rate of six per centum per annum until paid; interest to be computed and paid semi-annually and if unpaid when due to bear interest at same rate as principal until paid, and I have further promised and agreed to pay ten per cent of the whole amount due for attorney's fee, if said note be collected by attorney or through legal proceedings of any kind, reference being thereunto had will more fully appear.

in consideration of the said debt and sum of money

aforesaid, and for the better securing the payment thereof, according to the terms of the said note, and also in consideration of the further sum of Three Dollars, to me in hand well and truly paid at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Citizens Lumber Company, a corporation, its successors and assigns:

ALL that lot of land in Greenville County, South Carolina known and designated as Lot #49 on Crestmore Drive in the subdivision known as Grand-View as shown by a plat thereof made by Woodward Engineering Company, March, 1957 and recorded in the Greenville County R. M. C. Office in Plat BOOK "KK", at page 93, and having, according to said plat, the following metes and bounds:

BEGINNING at an iron pin on the northern side of Crestmore Drive at the corner of Lot #48 and running thence with the northern side of Crestmore Drive, N. 74-17 E., 32 feet to a concrete monument in the line of Lot #49; thence continuing with the line of Lot #49, N. 73-55 E., 28 feet to a pin at the corner of Lot #50; thence with the line of Lot #50, N. 15-43 W., 159.8 feet to a pin in the subdivision property line; thence with the subdivision property line, S. 74-17 W., 60 feet to a pin at the rear corner of Lot #48; thence with the line of Lot #48, S. 15-43 E., 160 feet to the point of beginning.
