All that lot of land in the County of Greenville, State of South Carolina, known and designated as Lot No. 257 on plat of AUGUSTA ACRES subdivision, recorded in Plat Book S, page 201 of the R.M.C. Office for Greenville County, S. C., said lot having a frontage of 100 feet on the eastern side of Chatham Drive, a depth of 227.1 feet on the northern side, a depth of 219.6 feet on the southern side, and a rear width of 100.3 feet.

Together with all and singular the rights, members, hereditaments, and appurtenances to the same belonging or in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures and equipment now or hereafter attached to or used in connection with the real estate herein described.
