DONALD E. BALTZ (hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of Twelve Thousand and No/100 -----

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the eastern side of Cherokee Drive near the City of Greenville, being shown as Lot 64 on Map No. 2 of Cherokee Forest recorded in Plat Book EE, Page 191, and described as follows:

BEGINNING at a stake on the northern side of Cherokee Drive 175 feet south from Gail Avenue at the corner of Lot 65 and running thence with the eastern side of said drive S. 32-49 E. 100 feet to a stake the corner of Lot 63; thence with the line of said lot N. 56-30 E. 180.6 feet to a stake at the corner of Lot 39; thence with the line of said lot N. 33-30 W. 100 feet to a stake at the corner of Lot 65; thence with the line of said lot S. 56-30 W. 179.4 feet to the beginning corner.
