To ALL WHOM THESE PRESENTS MAY CONCERN: I, **Woodrow Winchester,**

**Greenville, S.C.**, hereinafter called the Mortgagor, send(s) greetings:

WHEREAS, the Mortgagor is well and truly indebted unto  
**RATTERREE-JAMES INSURANCE AGENCY**
