ROBERT F. CAMBY AND VERA B. CAMBY

(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto CAROLINA FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, Greenville, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of Nine Thousand and No/100ths----- DOLLARS (\$ 9,000.00), with interest thereon from date at the rate of six----- per centum per annum, said principal and interest to be paid as therein stated, and

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

All that piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in Butler Township, Greenville County, South Carolina being known and designated as Lot No. 102 as shown on a plat entitled "Sub-division for W. C. Stewart" prepared by Woodward Engineering Co. Inc. dated March 1946, and recorded in the R.M.C. Office for Greenville County in Plat Book NN at page 200 and having according to said plat the following metes and bounds:

BEGINNING at an iron pin on the Westerly side of Saul Road at the joint front corner of Lots Nos. 101 and 102 and running thence with the line of Lot No. 101 S. 77-05 W. 165 feet to an iron pin; thence with the line of property now or formerly of Carolina Awning Co., S. 12-55 E. 90 feet to an iron pin at the joint rear corners of Lots Nos. 102 and 103; thence with the line of Lot No. 103, N. 77-05 E. 159.9 feet to an iron pin on the Westerly side of Saul Road; thence with the Westerly side of Saul Road, N. 9-28 W. 90.2 feet to the point of beginning.
