ALL that lot of land with the buildings and improvements thereon, situate on the Southeast side of Parisview Avenue, at Travelers Rest, in Bates Township, Greenville County, South Carolina, being shown as Lot No. 12 on plat of Sunny Acres, made by J. C. Hill, August 24, 1953, revised March 1, 1954, recorded in the RMC Office for Greenville County, S. C., in Plat Book "BB", pages 168 and 169; said lot fronting 80 feet along the Southeast side of Parisview Avenue, running back to a depth of 144.6 feet on the Northeast side, to a depth of 143.6 feet on the Southwest side and being 80 feet across the rear.
