WHEREAS, the Mortgagor is well and truly indebted unto
CANAL INSURANCE COMPANY

, a corporation organized and existing under the laws of the State of South Carolina, hereinafter called the Mortgagee, as evidenced by a certain promissory note of even date herewith, the terms of which are incorporated herein by reference, in the principal sum of Fourteen Thousand Seven Hundred Dollars (\$ 14,700.00), with interest from date at the rate of Five and one-fourth per centum (5 1/4 %) per annum until paid, said principal and interest being payable at the office of Canal Insurance Company in Greenville, South Carolina, or at such other place as the holder of the note may designate in writing, in monthly installments of Eighty-eight and 20/100----- Dollars (\$ 88.20), commencing on the first day of July, 1958, and on the first day of each month thereafter until the principal and interest are fully paid, except that the final payment of principal and interest, if not sooner paid, shall be due and payable on the first day of June, 19 83.

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt and for better securing the payment thereof to the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell, and release unto the Mortgagee, its successors and assigns, the following-described real estate situated in the County of Greenville, State of South Carolina:

ALL that lot of land with the buildings and improvements thereon, situate on the Northeast side of Elaine Avenue near the City of Greenville, in Greenville County, S. C., being shown as Lot No. 36 on plat of property of William M. Edwards, made by Dalton & Neves, Engineers, January, 1952, recorded in the RMC Office for Greenville County, S. C., in Plat Book "S", at page 12; said lot fronting 75 feet along the Northeast side of Elaine Avenue; and running back to a depth of 267.3 feet on the Southeast side, to a depth of 270.1 feet on the Northwest side, and being 75.05 feet across the rear.

THIS is the same property conveyed to me by deed of William M. Edwards and others, dated March 21, 1956, recorded in the RMC Office for Greenville County, S. C., in Deed Book 548, page 477.
