WHEREAS, the Mortgagor is well and truly indebted unto General Mortgage Co.

, a corporation organized and existing under the laws of the State of South Carolina, hereinafter called the Mortgagee, as evidenced by a certain promissory note of even date herewith, the terms of which are incorporated herein by reference, in the principal sum of Ten Thousand and Two Hundred - - Dollars (\$10,200.00), with interest from date at the rate of five and one-quarter per centum (5- $\frac{1}{4}$ %) per annum until paid, said principal and interest being payable at the office of General Mortgage Co. in Greenville, South Carolina, or at such other place as the holder of the note may designate in writing, in monthly installments of Sixty One and 20/100 - - - - - Dollars (\$ 61.20), commencing on the first day of July, 19 58, and on the first day of each month thereafter until the principal and interest are fully paid, except that the final payment of principal and interest, if not sooner paid, shall be due and payable on the first day of June, 19 83.

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt and for better securing the payment thereof to the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell, and release unto the Mortgagee, its successors and assigns, the following-described real estate situated in the County of Greenville, State of South Carolina:

All that certain piece, parcel or lot of land, situate, lying and being on the South side of Crosby Circle, in Gantt Township, Greenville County, State of South Carolina, being shown as Lot No. 132 on plat of Paramount Park made by Piedmont Engineering Service, July, 1949, and recorded in the R. M. C. Office for Greenville County in Plat Book "W" at Page 57, and having according to said plat the following metes and bounds, to wit:

BEGINNING at an iron pin on the South side of Crosby Circle, joint front corner of Lots Nos. 132 and 131, and running thence along the joint line of said lots, S. 26-0 E., 150 feet to an iron pin; thence running S. 64-0 W., 70 feet to an iron pin, joint rear corner of Lots Nos. 132 and 133; running thence along the joint line of said lots, N. 26-0 W., 150 feet to an iron pin on the South side of Crosby Circle, said pin being 1,480 feet from Dorr Drive; running thence along the South side of Crosby Circle, N. 64-0 E., 70 feet to the point of BEGINNING.

Together with all and singular the rights, members, hereditaments, and appurtenances to the same belonging or in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures and equipment now or hereafter attached to or used in connection with the real estate herein described.

To HAVE AND TO HOLD, all and singular the said premises unto the Mortgagee, its successors and assigns forever.
