TO ALL WHOM THESE PRESENTS MAY CONCERN:

JOE M. TIMMONS AND EVA H. TIMMONS (hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto CAROLINA FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, Greenville, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of Six Thousand Five Hundred and No/100ths-----

DOLLARS (\$ 6,500.00), with interest thereon from date at the rate of six----- per centum per annum, said principal and interest to be paid as therein stated, and

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

All that piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the Western side of Phillips Avenue in Paris Mountain Township, being shown as Lot No. 15 on plat of property of Joe A. Phillips, recorded in Plat Book AA at Page 179 and having according to said plat the following metes and bounds, to-wit:

BEGINNING at a stake on the Western side of Phillips Avenue at joint front corner of Lots 14 and 15 and running thence with the Western side of Phillips Avenue N. 0-15 W. 126 feet to a pin at corner of Lot 16; thence with the line of Lot 16 S. 74-47 W. 192 feet to an iron pin, corner Lot 21; thence with the line of Lot 21 S. 4-33 E. 125 feet to pin at rear corner of Lot 14; thence with the line of Lot 14 N. 74-16 E. 181 feet to the beginning corner.
