with interest thereon from the date hereof at the rate of 5 1/2 per centum per annum, ~~said interest to be paid on the~~

and principal sum to be paid in installments as follows: Beginning on the 1st day

of July 19 58, and on the 1st day of each month thereafter the

sum of \$ 79.95 to be applied on the interest and principal of said note, said payments to continue

up to and including the 1st day of May, 1983, and the balance

of said principal sum to be due and payable on the 1st day of June, 1983;

the aforesaid monthly payments of \$ 79.95 each are to be applied first to interest at the rate

of 5 1/2 per centum per annum on the principal sum of \$ 13,000.00 or so much thereof as shall
