SEND GREETING:

WHEREAS, the said mortgagor is indebted in and by a certain note of even date herewith for the principal sum of Eleven Thousand, Five Hundred and No/100 (\$11,500.00) Dollars, bearing interest at the rate of ~~five per cent per annum, payable semi-annually~~ six per cent per annum, payable monthly, said note being payable to the order of The Life Insurance Company of Virginia, a corporation, at its Home Office, Richmond, Virginia, in installments as follows:

Payable in 240 monthly instalments due respectively July 1, 1958, and monthly thereafter; the first 239 instalments to be for \$82.39 each, and the final instalment to be for the remaining balance of principal, plus accrued interest thereon. Payment of each monthly instalment when received by noteholder shall be first applied to accrued interest at the rate of 6% per annum on the then outstanding balance of principal and the residue of said instalment payment to be applied to reduction of principal.

NOW KNOW ALL MEN, That the said mortgagor in consideration of the said Debt and Note aforesaid, and for the better securing the payment of the same or of any renewal or extension thereof in whole or in part, and the performance of the covenants herein contained, to the said The Life Insurance Company of Virginia, according to the condition of the said Note, and also in consideration of the further sum of one dollar to said mortgagor in hand well and truly paid by the said Company at and before the sealing and delivery of these Presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released and by these Presents do grant, bargain and sell and release, unto the said The Life Insurance Company of Virginia, its successors and assigns the following property situated in the

County of Greenville City or Town of Greenville, State of South Carolina, to wit:

All that certain piece, parcel or lot of land situate, lying and being near the City of Greenville, in the County of Greenville, State of South Carolina, on the southeastern side of Princess Avenue (formerly Edgewood Drive) and being known and designated as Lots 7 and 8 on a plat prepared by Pickell and Pickell, Engrs., dated April 12, 1954, entitle "Subdivision of Property of Tom W. and Elsie Tucker" recorded in the RMC Office for Greenville County, South Carolina, in Plat Book HH, page 112, and having according to a more recent survey prepared by Pickell and Pickell, Engrs., dated August 26, 1954, and revised May 7, 1958, entitled "Property of William F. McClain and Bertie S. McClain" the following metes and bounds, to-wit;

BEGINNING at an iron pin on the southeastern side of Princess Avenue at the joint front corner of Lots Nos. 6 and 7 of the aforementioned subdivision, said iron pin being 1,145 feet, more or less, from the intersection of Princess Avenue and Welcome Road, and running thence along the line of Lot No. 6 S 78-28 E 200 feet to an iron pin; thence S 45-00 E 69.3 feet to an iron pin; thence along the rear line of Lots Nos. 7 and 8 S 59-15 W 389.8 feet to an iron pin; thence N 50-19 W 16.6 feet to an iron pin on the southeastern side of Princess Avenue; thence along the southeastern side of Princess Avenue N 20-20 E 296.2 feet to the point of beginning.

The mortgagor shall create a fund for payment of all taxes, special assessments and insurance premiums by depositing with the noteholder, on the days payments on account of principal and interest are due hereunder, an amount to be fixed from time to time by the noteholder, and there shall be no interest on said deposit.

The debt hereby secured having been paid in full, the lien of the within mortgage is satisfied this 23 day of August, 1965
