TO ALL WHOM THESE PRESENTS MAY CONCERN:

W.E. SHAW AND W.N. LESLIE

(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto CAROLINA FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, Greenville, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of Ten Thousand Two Hundred Fifty and No/100ths-----
DOLLARS (\$ 10,250.00), with interest thereon from date at the rate of six-----
per centum per annum, said principal and interest to be paid as therein stated, and

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purpose, and

WHEREAS, the unpaid balance of said debt or debts, if not sooner paid, shall be due and payable,
June 1, 1973

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

All that piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being on the Eastern side of Saul Road near the City of Greenville, Greenville County, South Carolina, in Butler Township, being known and designated as Lot No. 105 as shown on a plat entitled "Subdivision for W.C. Stewart", dated March, 1946, prepared by Woodward Engineering Co. Inc., and recorded in the R.M.C. Office for Greenville County, South Carolina in Plat Book NN at page 200, and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin in the turnaround at the Southern end of Saul Road at the joint front corner of Lots Nos. 104 and 105, and running thence with the line of Lot No. 104 S. 12-15 E. 40.4 feet to an iron pin; thence with the line of North Garden, Section I, N. 76-13 E. 175.1 feet to an iron pin; thence with the line of North Garden, Section II, N. 12-15 W. 87.3 feet to an iron pin at the joint rear corner of Lots Nos. 105 and 106; thence with the line of Lot No. 106 S. 77-05 W. 125.1 feet to an iron pin on the Eastern side of the turnaround of Saul Road; thence with the curve of the turnaround of Saul Road, the chord of which is S. 31-51 W. 70.3 feet to the beginning corner.

This is the same property conveyed by Leslie & Shaw, Inc. to the mortgagors herein by deed dated May 22, 1958, and to be recorded herewith in the R.M.C. Office for Greenville County, South Carolina.
