until paid; interest to be computed and paid annually and if unpaid when due to  
bear interest at same rate as principal until paid, and I have further promised and agreed to pay ten per  
cent of the whole amount due for attorney's fee, if said note be collected by attorney or through legal proceed-  
ings of any kind, reference being thereunto had will more fully appear.

NOW, KNOW ALL MEN, That I , the said Carolyn M. Galloway (formerly Carolyn R.

in consideration of the said debt and sum of money  
aforesaid, and for the better securing the payment thereof, according to the terms of the said note, and also in  
consideration of the further sum of Three Dollars, to me in hand well and truly paid at and before the sealing  
and delivery of these presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold and  
released, and by these presents do grant, bargain, sell and release unto the said South Carolina National  
Bank, Greenville, S. C., its Successors and Assigns:

All that piece, parcel or lot of land with the buildings and improvements thereon  
in Gantt Township, Greenville County, State of South Carolina, about eight miles  
South of the City of Greenville, on the West side of Augusta Road, beginning at the  
corner of land conveyed to Carolyn R. Myer, by deed dated March 1, 1946, recorded in  
the R. M. C. Office for Greenville County, South Carolina, in Deed Volume 288, page  
207, and running thence along U. S. Highway No. 25 S. 13-49 W. 84 feet to an iron pin  
at the corner of property of the grantor; thence N. 85-13 W. 190 feet to an iron pin;  
thence N. 3-00 E. 84 feet to a stone; thence S. 84-00 E. 206 feet to an iron pin, the  
point of beginning, and also;

All that piece parcel or lot of land with the buildings and improvements thereon in  
Gantt Township, Greenville County, State of South Carolina, about eight miles from
