MORTGAGE OF REAL ESTATE

To All Whom These Presents May Concern:

I, Jack E. Shaw of Greenville County

SEND GREETINGS:

WHEREAS, I/we the aforesaid mortgagor(s) in and by my/our certain promissory note, in writing, of even date with these presents am/are well and truly indebted to FIRST FEDERAL SAVINGS & LOAN ASSOCIATION OF GREENVILLE, in the full and just sum of Eleven Thousand Two Hundred Fifty & (\$11,250.00) Dollars (or for future advances which may be made hereunder at the option of said Association, which advances shall not exceed the maximum amount stated herein and shall be evidenced by a subsequent promissory note or notes secured hereby), said note to be repaid with interest at the rate specified therein in installments of Eighty Five and 30/100. (\$85.30) Dollars upon the first day of each and every calendar month hereafter in advance, until the full principal sum, with interest, has been paid, such monthly payments to be applied first to the payment of interest, computed monthly on the unpaid principal balances, and then to the payment of principal. The last payment on said note, if not paid earlier and if not subsequently extended, will be due and payable 18 years after date. BEGINNING at an iron pin on the eastern side of Nora Drive, at the joint front corner of Lots 7 and 8 and running thence along the joint line of said lots, N. 79-10 E, 190 feet to an iron pin, joint rear corner of Lots 7 and 8; thence along the rear line of Lot 7, N. 10-50 W. 83.2 feet to an iron pin; thence turning and running S. 78-00 W. 190 feet to an iron pin on the Eastern side of Nora Drive; thence along the eastern side of Nora Drive, S. 10-50 E. 80 feet to an iron pin, the point of beginning; being the same property conveyed to me by C. C. Davis by his deed dated June 11th, 1958 to be recorded herewith.
