TO ALL WHOM THESE PRESENTS MAY CONCERN:

I, William L. Costner

(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of **Eleven Thousand and No/100-----**

**DOLLARS (\$ 11,000.00**), with interest thereon from date at the rate of **Six (6%)** per centum per annum, said principal and interest to be repaid as therein stated, and

--WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purpose:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville,

being known and designated as lot # 293 in Section III of Belle Meade, recorded in Plat Book GG at Page 187 in the R.M.C. Office for Greenville County and described as follows:

BEGINNING at an iron pin on the northern side of Lancaster Lane, at the joint front corner of lots # 292 and 293, and running thence with the line of lot # 292, S. 50-35 W. 161.5 feet to iron pin; thence N. 26-13 W. 88.6 feet to iron pin, rear corner of lot # 293; and 294; thence with the line of lot # 294, S. 48-32 W. 181.3 feet to iron pin on Lancaster Lane; thence with said Lancaster Lane, S. 39-05 E. 80 feet to the point of beginning."

Being the same premises conveyed to the mortgagor by Derby Heights, Inc. to be recorded.
