Fuller in hand well and truly paid by the said Modern Homes Construction Company at and before the sealing and delivery of these Presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these Presents DO GRANT, bargain, sell and release unto
Modern Homes Construction Company

All that certain piece, parcel or lot of land, situate, lying and being in the County of Greenville, State aforesaid, near Phillips Lake, on the E/S of the South Saluda River, W/S of Sherwood Road, and having, according to a plat of survey made by R. B. Bruce, surveyor, June 8, 1957, the following metes and bounds, courses and distances to-wit:
BEGINNING at an iron pin on the W/S of Sherwood Road, joint corners of lots 4 and 5 and running thence S 30-49 W 123.9 to a point of the edge of said river: thence following the bank of said river N 45-55 W 132.3 feet to an iron pin; thence N 41-16 E 112.8 feet to an iron pin on edge of said road; thence following said road S 50-04 E 109.7 feet to the beginning corner, being all of Lot No. Four (4).
