WHEREAS, the Mortgagor is well and truly indebted unto

organized and existing under the laws of the State of South Carolina, hereinafter
called the Mortgagee, as evidenced by a certain promissory note of even date herewith, the terms of which
are incorporated herein by reference, in the principal sum of Ten Thousand Two Hundred Fifty
Dollars (\$10,250.00), with interest from date at the rate of five & one fourth per centum
(5 $\frac{1}{4}$ %) per annum until paid, said principal and interest being payable at the office of
General Mortgage Co. in Greenville, South Carolina,

and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained,
sold, and released, and by these presents does grant, bargain, sell, and release unto the Mortgagee, its
successors and assigns, the following-described real estate situated in the County of Greenville,
State of South Carolina:

ALL that lot of land with the buildings and improvements thereon, situate
on the East side of Lander Street, in the City of Greenville, in Green-
ville County, S. C., being shown as Lot 111 on plat of College Heights,
made by Dalton and Neves, Engineers, August 1946, recorded in the R.M.C.
Office for Greenville County, S. C. in Plat Book "P", page 75, said lot
fronting 72 feet along the east side of Lander Street, running back
to a depth of 155.4 feet on the North side, to a depth of 155 feet on the
South side, and being 83.5 feet across the rear.
